We, the undersigned, desiring to become incorporated under the provisions of Act No. 327, P. A. 1931, as amended, do hereby make, execute and adopt the following articles of association, to-wit:

First, The name assumed by this corporation and by which it shall be known in law, is.....

Second, The location of said church or society shall be in the City of Detroit,

Third, The time for which said corporation shall be created shall be perpetual

Fourth, The members of said church or society shall worship and labor together according to the discipline, rules and usage of the Baptist church in the United States of America (or other jurisdiction as the case may be), as from time to time authorized and declared by the National Baptist Convention

Fifth, (Here insert any desired additional provisions authorized by the Act).

1. All meetings must be called by the minister of the Church, no meeting can be called without the minister's authorizing the call of the Church meeting.
2. All directors of the Little Rock Missionary Baptist church shall be appointed by the Pastor or be dismissed by his descretion.
3. Governed by the principle of Jesus Christ and the New Testament of the Bible.
