CERTIFICATE OF AMENDMENT TO ARTICLES OF  
ASSOCIATION OF  
THE NORTH WOODWARD METHODIST EPISCOPAL  
CHURCH

Postoffice Address, Detroit, Mich.

We, the undersigned, being two-thirds of the members of the quarterly conference of the North Woodward Methodist Episcopal Church of Detroit, Michigan, and being a corporation organized and existing under the laws of the State of Michigan, do hereby certify as follows:

That at a regular meeting of the quarterly conference of said The North Woodward Methodist Episcopal Church held in the City of Detroit on Monday, the 8th day of November, 1926, IT WAS RESOLVED by more than a two-thirds vote of all of the members of said quarterly conference that Article No. I of the Articles of Association of said corporation be, and the same is amended so as to read as follows:

FIRST

The name assumed by this corporation and by which it shall be known in law is THE METROPOLITAN METHODIST EPISCOPAL CHURCH, of Detroit, Michigan.
